



1. DEFINATION

2. MEMBERSHIP

Membership shall be open to 'any male or female above the age of 18 years and interested in social welfare work and who will abide by the rules and objectives of the society is eligible for membership one will have to submit petition for membership which will duly be approved by the Managing Committee. The admission fee will be Rs. 510/- and yearly fee will be Rs. 250/-

3. APPLICATION FOR ADMISSION.

- A. Every application for the admission as member of the society shall be addressed to the Secretary of the society
- B. No application shall be considered unless the applicant is proposed by a member and seconded by another such member.
- C. Every such application shall be considered in the meeting of the Managing Committee and shall be accepted or rejected by a vote of majority save as those failing under rule -4 of these rules.
- D. Every applicant shall be informed in writing by the secretary of the decision of the Managing committee which shall be final.

4. TERMINAL OF THE MEMBERSHIP.

- A. By failing the payment of his annual membership fee without reasonable ground.
- B. By resignation.
- C. By failing to attend three meeting without information.
- D. By death.
- E. By unsound mind.
- F. By order of the Secretary if any member will not abide with the rules of the society or if found guilty or misconduct

All general body meeting 3/5th person shall form a quorum. If the quorum is not present within half an hour of the fixed time the meeting shall be adjourned to the same date and time and at the same place for the next week and if the quorum is not present at the adjourned meeting too the members present shall be deemed to form quorum.

The notice of the General body meeting shall contain item of business to be transacted and with mention of place and time shall be issued to all members at least 15 days before the meeting.

9. GENERAL BODY

The annual general body meeting shall be held at least one in a year at such time and place as fixed by the Secretary,

10. POWER OF FUNCTION OF THE OFFICER BEARERS.
PRESIDENT.

- I. He shall present conduct and regulate all the meeting and his ruling one any point of order and decision shall be final conclusive.
- II. He shall have a general administrative control over the work of the society in all matter.
- III. The President shall have the power to call meeting of the society.

SECRETARY.

- I. The Secretary shall be the Chief Executive of the society, and his duties shall be subject to the control and direction of the Governing Body of the Society.
- II. He shall issue all notice of the all meeting with the permission of the President.
- III. He shall keep the proceedings of all meetings, all records and shall make all correspondence on behalf of the society.
- IV. He is entitled to see or defend any suit or proceedings on behalf of the society under the direction of the managing committee.
- V. He shall collect money and issued receipt for the same.
- VI. He shall place a provisional budget every year for approval of the Governing body, He shall not be entitled to spend more than 10,000/in society in hand the balance amount to be deposited in the bank.

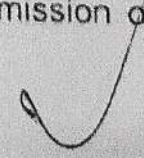
TREASURER

- entitled to keep Rs. 500/- in cash in hand.
- ii. He shall maintain all accounts in proper books as directed by the managing committee.
 - iii. He shall place the financial position for the society in every meeting of the governing body.
 - iv. He shall be responsible to maintain the accounts of the society properly and regularly and the accounts shall be audited by the auditor appointed by the general body. The same audited statement of accounts shall be submitted to the Secretary in time.

11. **BANK OPERATION**

The account of the society shall be kept properly and the Bank Account will be opened in a Nationalized Bank or post office in the name of the society and it will be operated by joint signature of Treasurer and Secretary. The treasurer will initiate the cheque and hence will sign on the left hand and Secretary will sign on the right side of the cheque.

12. **SOURCE OF INCOME**

- A. By donation from its members, other individuals, public / government companies or firm(s)/private firms/ companies and organizations and institutions running under society.
- B. By aids from legal sources or anonymous aid.
- C. Any other legal sources.

13. **INSPECTION OF THE RECOREDS.**

All records will be kept in registered office. Any member wishing to inspect can do so with the prior permission of the President or Secretary.

14. **AUDIT OF ACCOUNTS.**

- A. The accounts of the society shall be audited at least once a year by an auditor appointed by the General body and it will be placed before the general body meeting.
- B. Inspector General of Registration, Bihar on his discretion any time, may get audited account of the society by recognized chartered accountant and the fee will be borne by the society.

16. AMENDMENT OF RULES.

The rules will not be amended to our altered unless two third members of the society have agreed to the proposed amendment for alteration in a General body meeting provided at least one months notice has been given to the members about the proposed amendment.

17. INFORMATION OF MEETING.

- A. Information of meeting will be given to executive body 7 days before.
- B. Information for meeting of general body will be given 15 days before.
- C. Information for urgent and necessary meeting will be given 48 hrs. before.
- D. Information of meeting will be given through Registered post / courier /e-mail or special messenger.

18. LEGAL PROCEEDING.

All the legal proceedings by or against the society shall be represented by the Secretary of the Society all documents executed by or in favour of the society shall be in the name of the Secretary of society.

19. DISSOLUTION.

- a. The society shall be dissolved according to the Rules of the societies. Registration Act 21, of 1860 by 3/5th majorities of the members of the society in the General body meeting.
- b. And after the dissolution the total movable and immovable properties of the society shall either be given to other society of the same aims and objects of the given to the Govt. after being paid all debts etc. of the society by 3/5th majority in general body meeting.
- c. The society will be dissolved after the permission of Bihar Govt. under section 13 of the society Registration Act. 21 of 1860.
